## **STATUS OF ASSESSED CONTRIBUTIONS TO EUROBATS**

The table below presents the payment status of assessed contributions to the EUROBATS Trust Fund as at the end of April 2026, including outstanding amounts from previous financial years and the current status of payments for 2026. For the financial year 2026, assessed contributions remain payable until 30 June 2026.

A total of **€358,799**, corresponding to about **65%** of the contributions invoiced for 2026 (€552,953), has been received. The total level of arrears, which relate exclusively to unpaid contributions from 2025 and earlier financial years, amounts to **€20,800** and is attributable to a limited number of Parties. The overall outstanding balance amounts to **€194,154**, the majority of which relates to contributions for 2026. The Parties are encouraged to complete any remaining payments for 2026 within the agreed timeframe in order to support the financial stability and effective implementation of the Agreement.

The Parties whose arrears exceed three years are reminded that their representatives are not eligible to receive funding for participation in meetings, in accordance with Resolution 9.1 on Financial and Administrative Matters.
