### Report of the Intersessional Working Group on 'Bats and Light Pollution'

The aim of the group is to assess the potential impact of artificial light on bats in Europe and to develop guidelines for the bat-friendly application of artificial light at night.

The subgroups reviewed the literature related to the topic of the IWG and finalized a report that was sent to all IWG members in advance of the 22<sup>nd</sup> AC meeting.

Co-convenor of the IWG, Christian Voigt, organized a workshop at the IZW in Berlin, Germany, in November 2016 that was financially supported by the Leibniz Institute for Zoo and Wildlife Research and by EUROBATS via money from the German BMUB. During the first day of this event, invited speakers reported the latest findings about the effect of artificial light at night on bats. Presented data was partly unpublished so that IWG members learned about the most recent advances in the field. This first day was open to the public.

During the two-day, non-public work following the scientific symposium, speakers and some IWG members met to discuss and file a first draft version of guidelines related to the bat-friendly use of artificial light at night. Further, the participants of this workshop finalized a draft for a resolution.
